**Terms and Conditions**

2. To enter the competition you must be resident in the UK (except Northern Ireland), Isle of Man or Channel Islands and be 18 years of age or older.
3. The following are not eligible to participate: employees and immediate family members of employees of any of The Carphone Warehouse Group plc, their subsidiaries, agents and advisors; or any other persons assisting with this competition.
